4.This Court is not expressing any opinion on the merits of the petitioner's representation.

5.No prejudice will be caused to the fourth respondent if the said authority is directed to survey and demarcate the boundaries of the petitioner's property, morefully described in the prayer to this writ petition, after hearing the objections if any from the respondents 5 and 6 as well as any other party whom the fourth respondent deems it fit. Accordingly, this writ petition is disposed of in the following manner:-

(a) Before surveying the lands in question, the fourth respondent is directed to issue notice to the respondents 5 and 6 and also to any other party, whom the fourth respondent deems it fit to put on notice.

(b) After receiving objections if any and after considering the same, the fourth respondent shall conduct survey and demarcate the boundaries of the property morefully described in the prayer to this writ petition, on merits and in accordance with law, within a period of 12 weeks from the date of receipt of a copy of this order.
