5.This Court is not expressing any opinion on the merits of the petitioner's applications.

6.For the foregoing reasons, this writ petition is disposed of by directing the second respondent to pass final orders, on merits and in accordance with law on the petitioner's applications dated 07.08.2024 and 10.12.2025 seeking for issuance of patta in his name for the property, morefully described in the prayer to this writ petition, after giving due consideration to the supporting documents filed by the petitioner and after hearing the objections of the neighbouring land owners, if any as well as any other third party whom the second respondent deems it fit to enquire, within a period of 12 weeks from the date of receipt of a copy of this order.
