PRAYER: Arbitration Application filed under Order XIV Rule 8 of Original Side Rules read with Section 9(1)(ii)(a)(b)(d) & (e) of the Arbitration and Conciliation Act, 1996, to appoint employee of the applicant viz.Mr.C.Prema Kumar Reddy, Area Legal Manager, as Receiver to seize and take possession of the vehicle which is more fully described in the schedule to the judges summons which is lying in the custody of respondent or respondent's men, agents, servants from respondent premises or wherever found with Police aid and break open of premises if necessary.

ORDER

When the matter came up for hearing on 17.11.2025, this Court passed the following order:

“This application has been filed under Section 9 of the Arbitration and Conciliation Act, 1996, [for brevity 'the Act'] for appointment of a receiver to seize and deliver the vehicle from the respondent to the applicant, if necessary, with police protection and by breaking open the premises.

2. Heard Mr.D.Pradeep Kumar, learned counsel for applicant and carefully perused the materials available on record.

3. It is seen that an award has already been passed on 19.06.2025 directing the respondent to pay a sum of Rs.7,85,218/-. The specific case of the applicant is that till date, the award has not been challenged. The applicant is also not able to take possession of the vehicle. According to the applicant, the total amount that is due and payable by the respondent is Rs.9,79,673.33/- as on 13.12.2025. It is under these circumstances, the present application has been filed before this Court.

4. Considering the fact that an award has been passed and the applicant must be able to recover the amount from the respondent, this Court is inclined to appoint a receiver.

5. Accordingly, Mr.C.Prema Kumar Reddy, Area

Legal Manager, is appointed as the receiver and the receiver is permitted to seize the vehicle from the respondent or wherever it is found and by breaking open the premises, if required with police assistance.

6. Notice to the respondent returnable by 23.02.2026.

Private notice is also permitted.

List this application on 23.02.2026.”

2. It is brought to the notice of this Court that the vehicle has been seized by the receiver. In spite of service of notice, there is no appearance for the respondent either in person or through counsel.

3. Since the vehicle has already been seized and handed over to the applicant, no further orders are required to be passed in this application.

Accordingly, this application stands closed.
