4. No prejudice would be caused to the respondents, if the petitioner's representation as stated supra is considered on merits and in accordance with law, after giving due consideration to the supporting documents filed by the petitioner, within a time frame to be fixed by this Court.

For the foregoing reason, this Court directs the 2nd respondent to pass final orders, on merits and in accordance with law, on the petitioner's representation, dated 30.10.2025 seeking for correction of FMB sketch for the property morefully disclosed in the affidavit filed in support of this writ petition, after giving due consideration to the supporting documents filed by the petitioner, within a period of twelve (12) weeks from the date of receipt of a copy of this order, after hearing the objections of all the necessary parties.

7. With the above directions, this Writ Petition is disposed of. There shall be no order as to costs.
