No.345/ 19 admeasuring 24 Sq. meters and S.F. No.345/31B admeasuring 31 Sq. meters situated at Thazhuthazhaimedu Village,Udayarpalayam Taluk, Ariyalur District in accordance with the provisions of RFCTLARR Act, 2013. However, the said representation was not at all considered by the respondent till date. Hence, this petition.
