PRAYER

Writ Petition filed under Article 226 of the Constitution of India, praying to issue a Writ of Certiorarified Mandamus,

to call for the records on the file of the 3rd respondent bearing proceedings No. Na.Ka.A1 / 493 / 2015 dated 4.12.2020 and quash the same as manifestly erroneous, unjust, illegal, perverse and unlawful and consequentially direct the respondents to Refund the sum of Rs.1,61,384/- to the petitioner together with interest from the date of deposit towards lease for shop NO.12 in Commercial Complex constructed under Anna Marumalrchi scheme in Tirukovilur Town

to call for the records on the file of the 3rd respondent bearing proceedings No. Na.Ka.A1 / 493 / 2015 dated 4.12.2020 and quash the same as manifestly erroneous, unjust, illegal, perverse and unlawful and consequentially direct the respondents to Refund the sum of Rs.1,51,592/- to the petitioner together with interest from the date of deposit towards lease for shop NO.2 in Commercial Complex constructed under Anna Marumalrchi scheme in Tirukovilur Town

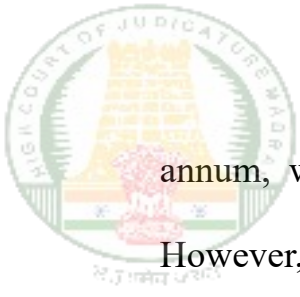

ORDER

Today, this matter is listed under the caption “for reporting compliance”.

2. The learned counsel appearing for the petitioner would submit that this Court, vide order dated 09.03.2026, had directed the 3rd respondent to refund the amount paid by the petitioner along with the interest at the rate of 12% per



annum, within a period of 4 weeks from the date of receipt of that order.

However, the said order has not been complied by the respondent till date.

Hence, he requests this Court to grant liberty to file a contempt petition against the respondents.

3. In reply, the learned counsel for the respondents would submit that the respondents had preferred an appeal against the aforesaid order passed by this Court and the same is yet to be numbered. Hence, they are not in a position to comply with the said order.

4. In view of the above, it appears that no further order is required in these petitions. The petitioner is granted liberty to file a contempt petition against the respondents for non-compliance of the order passed by this Court.
