Accordingly, this writ petition is disposed of by directing the third respondent to pass final orders, on merits and in accordance with law on the petitioner's representation seeking for issuance of patta in his name for the property, morefully described in the prayer to this writ petition, after hearing the objections of the fourth respondent and any other third party, if any, whom the third respondent deems it fit to enquire, within a period of 12 weeks from the date of receipt of a copy of this order.
