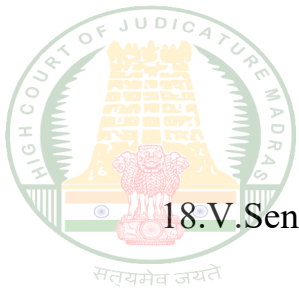

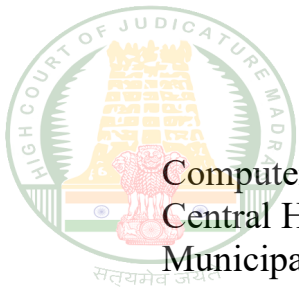

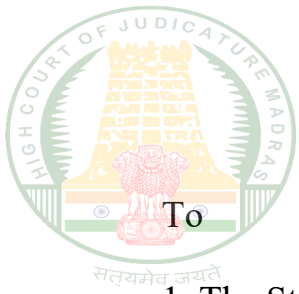
ORDER
