PRAYER: Writ Petition filed under Article 226 of the Constitution of India to praying to issue a Writ of Mandamus, directing the respondents 1 to 4 to consider the representation/ objection dated 28.12.2025 as against the notice dated 14.07.2025 in Na.Ka.A3.No.3470/2024 issued under Section 7 of the Tamil Nadu Land Encroachment Act, 1905 on the file of the 4th respondent and also forbear the respondents 1 to 4 from evicting the petition except in accordance with due process of law and direct the respondents 1 to 4 to issue Patta to the petitioner for the property admeasuring 0.25 Acre comprised in S.No.348 situated at Chinnamanur Village, Thirupattur Taluk.

5. In view of the same, the present Writ Petition is dismissed. No costs. Consequently, the connected miscellaneous petitions are closed.
