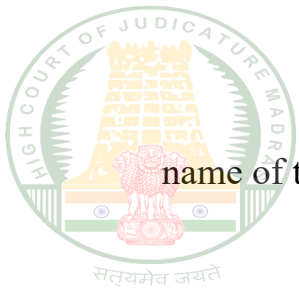

COMMON ORDER
