Prayer: Writ Petition is filed under Article 226 of the Constitution of India, praying to issue a Writ of Certiorarified Mandamus, to call for the records in Ne.Mu.P.A3/09/2018 dated 30.04.2018 on the file of the District Collector, Villupuram rejecting petitioner's appeal dated 21.01.2018 confirming his (District Collector's) own earlier order in N.K.P.A3/09/2018, dated



17.01.2018 and quash the same as ultra vires, unconstitutional against R1

of Law and against the principles of natural justice and consequently to direct the District Collector, Villupuram to revise and to fix (petitioner's) seniority in the seniority list dated 17.01.2018 in N.K.P.A3/09/2018 declared by the District Collector, Villupuram at Serial No.169 above Anjala instead of 287 following the direction issued by the Government in Government's letter No.21072/A6/7/2001-3 dated 31.01.2002 issued by the Rural Development Department, Government of Tamil Nadu and following the Government Order in G.O.Ms.No.447, Rural Development and Local Administration Department dated 19.08.2015.
