For the foregoing reasons, this Court directs the respondent to pass final orders on merits and in accordance with law on the petitioner's representation dated 10.01.2026, seeking for updation of the online entry of the revenue records in the official website of the Department of Survey and Settlement of Lands, Tamil Nadu and for issuance of a separate "Natham Patta"



in the name of the petitioner for the land morefully described in the prayer to this writ petition within a period of twelve weeks from the date of receipt of a copy of this order.

7. Accordingly, this writ petition is disposed of. No Costs.
