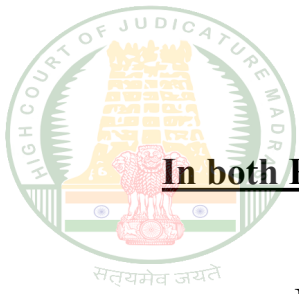

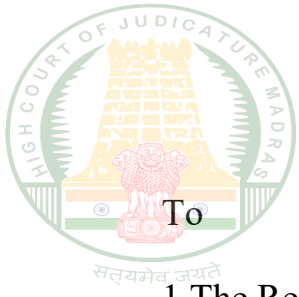
2. The learned Government counsel for the third respondent would submit that, in light of the said settlement, the third respondent has dropped all coercive action against the petitioner.
