Accordingly, this writ petition is disposed of by directing the third respondent to pass final orders, on merits and in accordance with law on the petitioner's representation dated 16.10.2025 seeking for issuance of computerised patta in his name for the property, morefully disclosed in the affidavit filed in support of this writ petition, after giving due consideration to the supporting documents filed by the petitioner, within a period of 12 weeks from the date of receipt of a copy of this order. No costs.
