PRAYER : Criminal Original Petition filed under Section 482 of Bharatiya Nagarik Suraksha Sanhita, to enlarge the petitioners on anticipatory bail in the event of petitioner arrest in pending investigation in Cr.No.25 of 2026, on the file of the respondent police.

ORDER

The petitioners, who apprehend arrest for the alleged offence under Sections 296(b), 118(1), 351(2) of BNS 2023 r/w 4 of Tamil Nadu Prohibition of Women Harassment Act in Cr.No.25 of 2026, on the file of the respondent police seek anticipatory bail.



2. The case of the prosecution is that there was a dispute between the petitioners and the defacto complainant regarding for parking of vehicle.

Due to which, the petitioners have abused and assaulted the defacto complainant and also injuries to him , which lead to the registration of an FIR. Hence, the present case.

3.The learned counsel appearing for the petitioners submitted that the the petitioners herein are ranked as A1 to A3 and it is a case and counter case and FIR has been registered against the defacto complainant and his family members in Cr.No.26 of 2026. He further submitted that the petitioners are ready to cooperate with the investigation. Hence, he prayed for grant of anticipatory bail to the petitioners.

4. The learned Government Advocate (Crl.Side) appearing for the respondent police reiterated the prosecution case and submitted that the injured has been discharged from the hospital, no previous cases reported against the petitioners and investigation in this case is pending . Hence, he vehemently opposed for the grant of anticipatory bail to the petitioners.

5. Heard both sides and perused the materials available on record.

6. Considering the nature of allegations and the fact that injured has been discharged from the hospital, though investigation in this case is pending and no previous cases reported against the petitioners, I am inclined



to grant anticipatory bail to the petitioners, subject to certain conditions.

7. Accordingly, the petitioners are ordered to be released on bail in the event of arrest or on their appearance within a period of fifteen (15) days from the date on which the order copy made, before the learned **Judicial Magistrate-Sriperumpathur** on condition that each of the petitioners shall execute separate bonds for a sum of **Rs.20,000/- (Rupees Twenty Thousand only) with two sureties** each for a like sum to the satisfaction learned Magistrate concerned, and on further condition that:

(a) If the petitioners fails to surrender before the concerned Magistrate within a period of fifteen (15) days from the date of receipt of a copy of this order, this order shall stand automatically cancelled;

(b) The sureties shall affix their photographs and left thumb impression in the application for surety ship (Judicial Form No.46 annexed to 'The Criminal Rules of Practice, 2019]'. The learned Magistrate shall obtain a copy of any one of identify proofs to ensure their identity;

(c) **The petitioners shall report before the respondent police daily at 10.30a.m., for a period of three weeks and thereafter, as and when required for interrogation;**

(d) On breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate actions against the petitioners in accordance with law as if

the conditions have been imposed and the petitioners released on anticipatory bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in ***P.K.Shaji v. State of Kerala [(2005) AIR SCW 5560]***;

(e) If the accused thereafter absconds, a fresh FIR can be registered under Section 269 of BNS Act.
