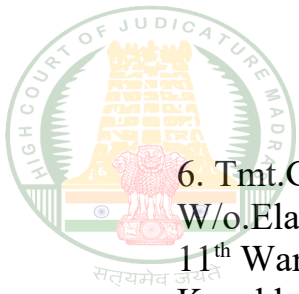

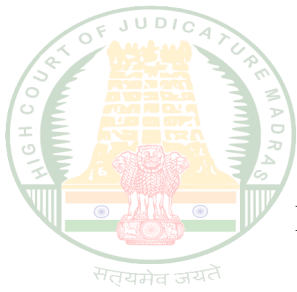
Prayer in W.P.Nos.3623 & 3633 of 2023: Petitions filed under Article 226 of the Constitution of India praying for issuance of a Writ of a Certiorarified Mandamus to call for the records of the impugned order passed by the 5th Respondent in Na.Ka.No.142/2021/Ka.Oo, dated 07.10.2021 and quash the same as illegal and consequently direct the Respondents 1 to 5 to immediately restore the Petitioner as the member of the 6th Ward of the 5th Respondent/Village Panchayat.

Prayer in W.P.No.34639 of 2022: Petition filed under Article 226 of the Constitution of India praying for issuance of a Writ of a Certiorarified Mandamus to call for the records of the impugned order passed by the 5th Respondent in Na.Ka. 2121/2020/A1 Date. 24.11.2022 in so far as, directing the petitioner to allow the respondents 5 and 6 to participate in the next meetings of the petitioner's panchayat till taking final decision by the 1st respondent on their disqualification, as illegal, improper and unconstitutional, consequently direct the respondents 1 and 2 to take a final decision on the proposal submitted by the petitioner dated 07.12.2022 on the disqualification of the respondents 5 and 6 as Ward members of Kanakkam Palayam Village Panchayat, Udumalpet, Tiruppur District within the time stipulated by this Honourable Court.

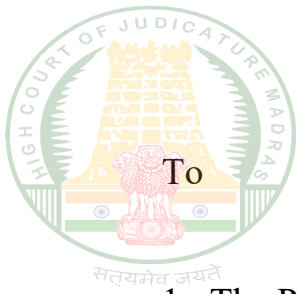
ORDER
