PRAYER

Directing the 1st and 2nd Respondents herein to survey the land sitauted at Ranipettai District, Arcot Taluk, Thamaraipakkam Village, Vide Patta No. 362, in New Survey No. 221/1A, to an extent of 357 sq.ft and in New Survey No.221/1A to an extent of 1320 sq.ft. on the basis of Challan No. 20251205063459 dated 05.12.2025 with help of necessary Police protection.

ORDER

This writ petition has been filed seeking for a direction to respondents 1 and 2 to survey and demarcate the property, which according to the petitioner is owned by him, within a time frame to be fixed by this Court.

2.Learned counsel for the petitioner submits that the petitioner had submitted an online application on 05.12.2025 for the aforesaid purpose. Since the same has not been considered till date, the petitioner has filed this writ petition.

3. Mr.C.Jayaprakash, learned Government Advocate accepts notice on behalf of respondents 1 and 2. Mr.R.Venkatatesa Perumal, learned Government Advocate (Crl.Side) accepts notice on behalf of the third respondent.

4.No prejudice will be caused to respondents 1 and 2 if the said authorities are directed to survey and demarcate the boundaries of the petitioner's property, morefully described in the prayer to this writ petition, after hearing the objections if any from the neighbouring land owners and any other party as they deem it fit. Accordingly, this writ petition is disposed of in the following manner:-

- (a) Before surveying the lands in question, respondents 1 and 2 are directed to issue notice to the neighbouring land owners and also to any other party, whom they deem it fit to put on notice.

(b) After receiving objections if any and after considering the same, the second respondent shall conduct survey and demarcate the boundaries of the property, morefully described in the prayer to this writ petition, on merits and in accordance with law, within a period of 12 weeks from the date of receipt of a copy of this order.

(c) If the need arises for police assistance and on a request made by the first respondent, the third respondent shall render police assistance for the effective implementation of this order.
