Prayer in WP.No.19609 of 2015 : Writ Petition is filed under Article 226 of Constitution of India, to issue a Writ of Certiorari Mandamus to call for the entire records relating to the impugned proceedings in No. 70 (38)(15)/11/TUFS/CBE dt 21.4.2015 issued by the 6th respondent and quash the same, further directing the respondents 4 to 6 to release claim of 20% Margin Money Subsidy under the Textile Up gradation Finance Scheme in relating to the petitioners firm viz M/s. Ravi Tex along with the interest charge by the respondents 1 to 3 for the subsidy amount, to restructure the petitioner loan accounts by adjusting the payments made by the petitioner to the loan accounts and consider the representation dt 16.3.2015 within stipulated period as fixed by this Honourable Court.

Prayer in WP.No.32998 of 2015 : Writ Petition is filed under Article 226 of Constitution of India, to issue a Writ of Certiorari to call for the entire records relating to the impugned notice in T11C/SLM.BO/LAO/2015-16 dated 06.10.2015 issued by the third respondent quash the same.
