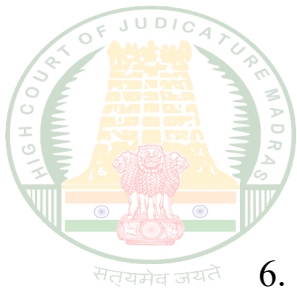
This Arbitration Original Petition has been filed under Section 11(6) of the Arbitration and Conciliation Act, 1996 to appoint an Arbitrator to adjudicate the claims and disputes between the petitioners and the respondents arising out of the Sub-Contract Agreement dated 07.06.2025.

2. Heard both sides.

3. When the matter is taken up, the learned counsel for the respondent had also expressed his consent for appointment of Arbitrator.

4. From a reading of the Sub-Contract Agreement dated 07.06.2025 entered to between the petitioner and the respondent, it could be seen that the parties have agreed to resolve the disputes by appointing an Arbitrator.
