Writ Petition (Criminal) is filed under Article 226 of the Constitution of India, to issue a Writ of Mandamus, directing the 6th respondent to provide police protection to survey, demarcate and fix the boundary of the land in T.S.No.137/2, measuring an extent of 1232 Sq.ft situated in Block No.6, Ward No.5, Pidari Amman Kovil Street, Thirupapuliur, Cuddalore by considering the petitioner representation dated 29.01.2026.
