WMP. No.6937 of 2026 is ordered subject to the payment of separate court fee.

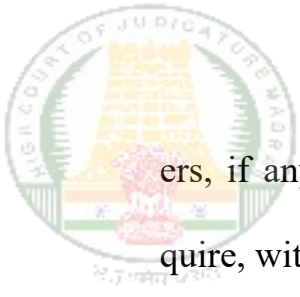
