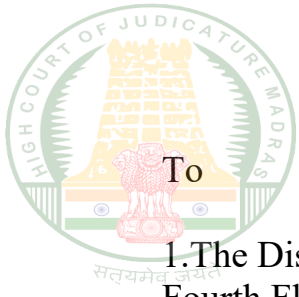
The present petition is filed to condone the delay of 23 days in filing the aforesaid appeal.
