Though some arguments are advanced by the learned counsel for the petitioner, ultimately, what has transpired is that with the elapse of time and the superannuation of the 5th respondent, nothing survives in this matter as on date.

2. The latest staff fixation order dated 30.10.2025 is produced before us which shows that there is only one post of B.T. Assistant and the second is surplus.

3. According to Ms.Lita, there is a crying need for a one more Maths



Teacher. In such an event, the school is at liberty to make a representation for consideration of a sanctioned post. Such representation as and when made, will be considered by the authorities expeditiously.

4. Recording the aforesaid position, the Writ Petition and the connected Miscellaneous Petition are closed. No costs.
