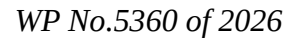

ORDER

The above Writ Petition has been filed seeking a direction to respondents 1 and 2 to consider the representation of the petitioner dated 13.01.2026 and consequently to direct the 3rd respondent bank to waive the entire interest and grant one year's time to settle the principal amount in respect of housing loan availed by the petitioner.

2. The petitioner would submit that he had availed a housing loan from the 3rd respondent bank by mortgaging his property through Memorandum of Title Deeds registered as Document No.8227 on the file of the Sub Registrar Office, Kelamangalam. He had been paying the monthly installments regularly. However, due to financial difficulties, the petitioner had defaulted in repayment. The petitioner had submitted a representation
