PRAYER:Writ Petition filed under Article 226 of the Constitution of India, praying to issue a Writ of Mandamus, (i) directing the 2nd respondent to restore the possession and management of the Rahmaniya Jumma Masjid and all its properties to its Hereditary Muthavalli and refrain from assumption of direct management except as per procedure established by law and pass such further or other order.



(ii) directing the 2nd respondent to render accounts of all collections, transactions, and operations pertaining to Rahmaniya Jumma Masjid or Rahmaniya Masjid Wakf from 22.12.2025 till date of restoration of possession of the Masjid and its properties to its Hereditary Muthavalli and pass such further or other orders.
