(a) Before surveying the lands in question, the second respondent is directed to issue notice to the neighbouring land owners and also any other party, whom the second respondent deems it fit to put on notice.

(b) After receiving objections if any and after considering the same, the third respondent shall conduct survey and demarcate the boundaries of the property, morefully described in the prayer to this writ petition, on merits and in accordance with law, within a period of 12 weeks from the date of receipt of a copy of this order.
