PRAYER : Criminal Original Petition filed under Section 483 of Bharatiya Nagarik Suraksha Sanhita, 2023, to grant bail to the petitioner/accused in Crime No.291 of 2025 on the file of the respondent police.

ORDER

The petitioner, who was arrested and remanded to judicial custody on 25.12.2025, for the offences punishable under Sections 296(b), 118(1), 109, 351(3) of BNSS, 2023, in Crime No.291 of 2025, registered on the file of the respondent police, seeks bail.



2. The case of the prosecution is that the petitioner herein is ranked as A2 in this case who joined hands with the other accused and went to the place of occurrence and attacked the defacto complainant with knife on his head and caused grievous injuries and hence, a case was registered by the respondent police.

3.The learned counsel appearing for the petitioner submitted that the petitioner is innocent and he has been falsely implicated in this case and he is in judicial custody from 25.12.2025 and the petitioner is ready to abide by any conditions that may be imposed by this Court. Hence, prays to grant bail to the petitioner.

4. The learned Government Advocate (Criminal Side) appearing for the respondent while opposing the bail to the petitioner, reiterated the prosecution case and submitted that the injured got discharged from the hospital and there is one previous case of similar in nature as against the petitioner and that the further investigation of this case is pending.

5. I have considered the submissions made and perused the materials available on record.



6. Considering the facts and circumstances of the case, though the petitioner has one previous case considering the period of incarceration undergone by the Petitioner since 25.12.2025, I am inclined to grant bail to the petitioner herein with certain conditions.

7. Accordingly, the petitioner is ordered to be released on bail on his executing a bond for a sum of **Rs.20,000/- (Rupees Twenty Thousand only)** with **two sureties each**, for a like sum to the satisfaction of the **learned District Munsif-cum-Judicial Magistrate, Gummidipoondi**, and on further conditions that:

[a] the sureties shall affix their photographs and Left Thumb Impression in the Application for Surety ship [Judicial Form No.46 annexed to 'The Criminal Rules of Practice, 2019']. The learned Magistrate shall obtain a copy of any one of the identity proofs to ensure their identity;

[b] **the petitioner shall report before the respondent police daily at 10:30 a.m., for a period of three weeks and thereafter, as and when required for interrogation;**

[c] On breach of any of the aforementioned conditions, the learned Magistrate/Trial Court is entitled to pass

appropriate orders against the petitioner in accordance with law as if the aforementioned conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in **P.K.Shaji vs. State of Kerala [(2005)13 SCC 283]**;

[d] If the accused thereafter absconds, a fresh FIR can be registered under Section 269 of B.N.S.
