This writ petition has been filed, seeking for a limited relief.

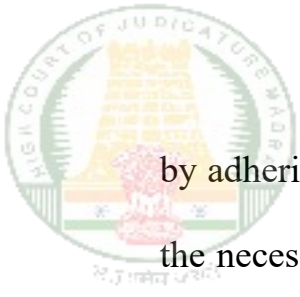
2. The petitioner seeks for early disposal of the petitioner's appeal dated 05.08.2025 pending on the file of the first respondent.
