This Writ Petition has been filed to direct the 1<sup>st</sup> respondent to correct the UDR patta issued in the name of the respondents 2 and 3 for the property morefully disclosed in the prayer to this writ petition.

2. The petitioner claims that erroneously UDR patta giving wrong description of the extent of the land has been issued for the property morefully disclosed in the prayer to this writ petition in favour of the respondents 2 and 3. The petitioner seeks for correction of the same through his representation dated 06.12.2025. Since the same was not considered till date, the petitioner has filed this writ petition.

3. Mr.D.Ravichander, learned Special Government Pleader, accepts notice on behalf of the 1<sup>st</sup> respondent. Since no adverse orders are passed against the respondents 2 and 3 in this writ petition, notice to the respondents 2 and 3 is dispensed with by this Court.

4. No prejudice would be caused to any of the respondents, if the petitioner's representation as stated supra is considered on merits and in accordance with law, within a time frame to be fixed by this Court.
