Accordingly, this writ petition is disposed of by directing the third respondent to pass final orders on the petitioner's representation dated 17.03.2025 seeking for issuance of patta in her name for the subject property, after hearing the objections if any from the neighbouring land owners as well as any other party whom the third respondent deems it fit to



enquire, within a period of 12 weeks from the date of receipt of a copy of this order. No Costs.
