3. Recording the same, the writ petition stands dismissed as withdrawn. No costs. Consequently, the connected miscellaneous petition is closed.

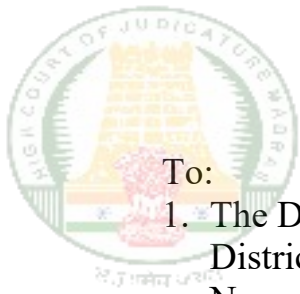
