ORDER

3. The learned counsel appearing for the petitioner would submit that this Court may issue direction to the 2nd respondent to pass appropriate orders on the petitioner's representation dated 22.12.2025 within a specified time.

4. The learned Government Advocate appearing for the respondents would submit that the 2nd respondent will consider the representation of the petitioner and pass appropriate orders on the same within a specified time.



5. In view of the above, there will be a direction to the 2nd respondent to consider the petitioner's representation dated 22.12.2025 and pass appropriate orders on the same in accordance with law, within a period of twelve weeks from the date of receipt of a copy of this order.

6. This Writ Petition is disposed of with the above terms. No costs.
Consequently, connected miscellaneous petition is closed.
