3. Mr.D.Ravichander, learned Special Government Pleader, accepts notice on behalf of the respondents 1, 3 and 5 and Mr.R.Venkatesa Perumal, learned Government Advocate (Crl.Side), accepts notice on behalf of the respondents 2, 4 and 6.

4. No prejudice would be caused to the respondents, if the 5th respondent is directed to survey and demarcate the boundaries of the petitioner's property morefully disclosed in the prayer to this writ petition, after hearing the objections, if any, from the neighbouring land owners as well as any other party whom they deem fit to put on notice within a time frame to be fixed by this Court. Accordingly, this writ petition is disposed of in the following manner:-

(a) Before surveying the lands in question, the 5th respondent is directed to issue notice to the neighbouring land owners, and also to any other party, if they deem fit to put on notice.

(b) After receiving objections if any and after considering the same, the 5th respondent shall conduct survey and demarcate the boundaries of the property morefully described in the prayer to this writ petition, on merits and in accordance with law, within a period of twelve (12) weeks from the date of receipt of a copy of this order.

(c) If the need arises for police assistance and on a request made by the 5th respondent, the 6th respondent shall render police assistance for the effective implementation of this order.

(d) There shall be no order as to costs.
