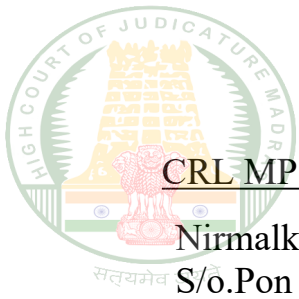

Prayer in CRL MP No. 3237 of 2025: Petition filed under Section 430 (1) of BNSS, 2023 to suspend the sentence and conviction dated 06.02.2024 passed against the petitioner / appellant in SC.No.23/2023 by the learned Principal Sessions Judge, Tiruppur to under go RI for 1 yr and fine Rs.1,000/- i/d RI for 3 months u/s.342 IPC to life Imprisonment to pay fine Rs,2000/- i/d RI for 3 moths u/s.302IPC to undergo RI for 7 yrs and to pay fine Rs.2000/- i/d RI for 3 months u/s.201 r/w 302IPC to undergo RI for 7 yrs and to pay fine Rs.2000/- i/d to undergo further RI for 3 months, u/s.307 IPC pending disposal of the above appeal.
