This Writ Petition has been filed praying for direction to the respondents to the petitioner a sum of Rs.4,500/- towards the IRT contributions, to pay the petitioner a sum of Rs.24,736/-towards the difference in pension for the period of April 2024 to August 2025 to pay the petitioner a sum of Rs.11,238/-towards the difference in surrendered Earned leave wages to pay the petitioner a sum of Rs.32,000/- towards arrears of difference in Dearness Allowances for the period from January 2017 to March 2017 to pay the petitioner a sum of Rs.12,500/-towards commutation amount together with interest at the rate of 12 percentage per annum and to pay the petitioner interest at the rate of 12 percentage per annum for the belated payment of Rs.11,24,133/- towards PF and for the belated payment of Rs.1,28,696/-towards earned leave/medical leave salary and for the belated payment of Rs.28,648/- towards surrendered earned leave salary within a specified frame as may be fixed by this Court.

4. With the above direction, this Writ Petition is disposed of. No costs.
