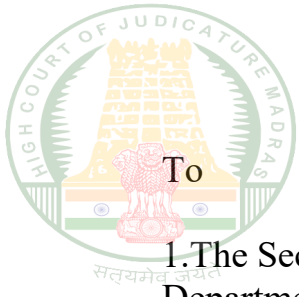
The learned counsel appearing for the petitioner seeks permission of this Court to withdraw this Writ Petition and has also made an endorsement to that effect.
