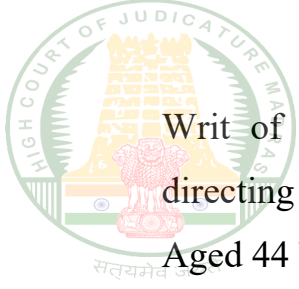

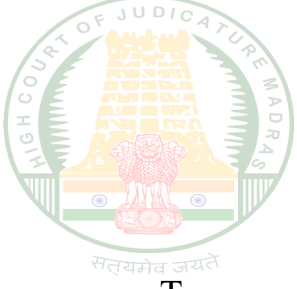
**ORDER****(Order of the Court was made by Dr.Anita Sumanth J.)**
