5.No prejudice would be caused to the respondents if the petitioner's representation seeking for restoration of his name in joint patta No.1156, is considered, on merits and in accordance with law, after hearing all the necessary parties, within a time frame to be fixed by the court.

6.For the foregoing reasons, this writ petition is disposed of by directing the third respondent to pass final orders, on merits and in accordance with law on the petitioner's representation dated 11.12.2025 seeking for restoration of his



name in joint patta No.1156 for the property, morefully disclosed in the prayer to this writ petition, after giving due consideration to the supporting documents produced by the petitioner and after hearing all the necessary parties, within a period of 12 weeks from the date of receipt of a copy of this order.
