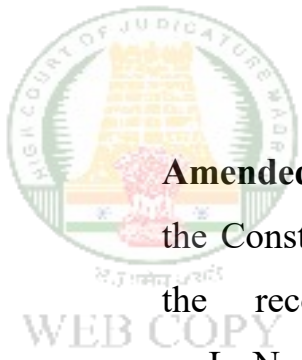

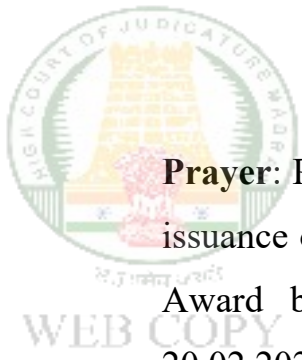

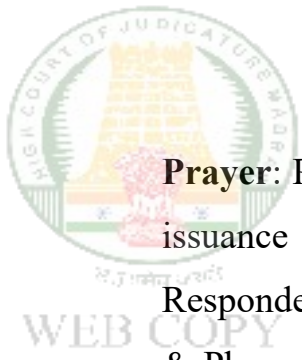

COMMON ORDER
