ORDER

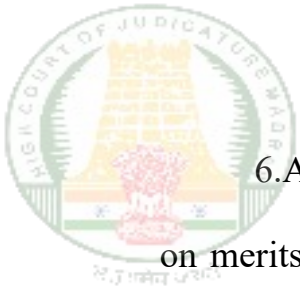

2.The petitioner had given representations on 06.05.2025 and 09.06.2025 to the respondents for the said purpose. Since the same have not been considered, the petitioner has filed this writ petition.

3.Mr.D.Ravichander, learned Special Government Pleader accepts notice on behalf of the respondents.

4.The competent authority to check the genuineness of Old Patta No.700 and New Patta No.1089, standing in the name of the petitioner for the property, morefully disclosed in the affidavit filed in support of this writ petition, is the third respondent.

5.No prejudice would be caused to the respondents if the petitioner's representations as stated supra, are considered, on merits and in accordance with law, within a time frame to be fixed by this Court.
