ORDER

This writ petition has been filed seeking to direct the respondent to include the name of the petitioner in the joint Patta Nos.839, 10573, 1116, 10272, 1582 and in connection with the Patta Nos.121/1, 2, 3, 4, 5 and 6, issued for the property more fully disclosed in the prayer to this writ petition.

2.According to the petitioner, her name has been erroneously excluded in the aforesaid Pattas. The petitioner seeks for inclusion of her name in the aforesaid Pattas. The petitioner had given a representation for the said purpose on 09.12.2025 to the respondent. Since the same has not been considered, the petitioner has filed this writ petition.

3.Mr.C.Jayaprakash, learned Government Advocate accepts notice on behalf of the respondent.

4.No prejudice will be caused to the respondent, if the petitioner's representation as stated supra is considered on merits and in accordance with law, after hearing the objections of all the persons in whose name the Patta Nos.839, 10573, 1116, 10272, 1582, and in connection with the Patta Nos.121/1, 2, 3, 4, 5 and 6 presently stand and any other necessary party, whom



the respondent deem fit to enquire, within a time frame to be fixed by this Court.
