ORDER

This writ petition has been filed, seeking for a direction to the respondent

2. The petitioner had submitted an application through on-line on 02.02.2026 for the aforesaid purpose. Since the same has not been considered till date, the petitioner has filed this writ petition.

3. Mr. C. Jayaprakash, learned Government Advocate accepts notice on behalf of the respondent.

4. No prejudice will be caused to the respondent if the said authority is directed to survey and demarcate the boundaries of the petitioner's property morefully described in the prayer to this writ petition, after hearing the objections if any from the neighbouring land owners as well as any other party, whom the respondent deems it fit to enquire. Accordingly, this writ petition is disposed of in the following manner:-

(a) Before surveying the lands in question, the respondent is directed to issue notice to the neighbouring land owners, and also to any other party, whom the respondent deems it fit to enquire.

(b) After receiving objections if any and after

considering the same, the respondent shall conduct survey and demarcate the boundaries of the property morefully described in the prayer to this writ petition, on merits and in accordance with law, within a period of 12 weeks from the date of receipt of a copy of this order.
