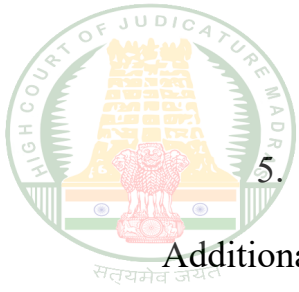
ORDER

Earlier, this Criminal Revision Case is disposed of by order dated 23.09.2025 with a direction to the Family Court to dispose of the case pending before it within a period of three months. Further this court observed that “since there was no specific term of compromise regarding the child’s maintenance, the minor child is entitled to independently claim maintenance.”
