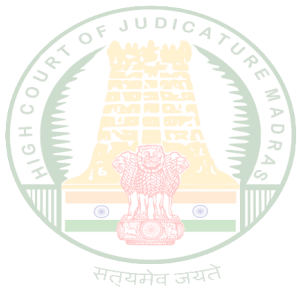

ORDER

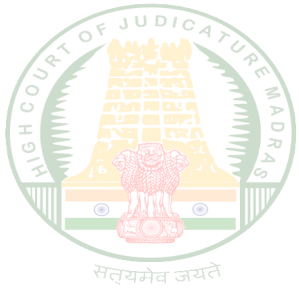

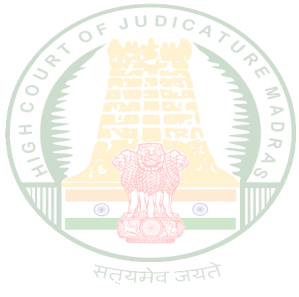
