When the matter was taken up for hearing, the learned counsel for the petitioners submitted that the petitioners are ready to furnish sureties, however, the learned Magistrate is insisting upon the production of original property documents to prove the solvency of the sureties. Hence, he seeks for appropriate directions.

3. Considering the submissions, this Court is of the view that the insisting upon production of original property documents to prove the solvency of the sureties, is not necessary. The execution of a personal bond for Rs. 20,000/- with two sureties to the satisfaction of the learned Magistrate is sufficient.

4. Accordingly, this Criminal Miscellaneous Petition is disposed of with a direction to the learned Magistrate to accept the sureties with proper proof of identity and residence, without insisting on the production of original property documents.
