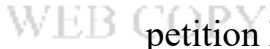

This Writ Petition has been filed seeking issuance of a Writ of Mandamus, directing the respondents to consider the representation of the petitioner dated 09.02.2026, wherein and whereby, she has sought grant of six days' emergency leave with escort, to her son, Harish @ Hariharan, S/o.Murugavel, Life Convict bearing Prisoner I.D.No.444036, presently confined in the Central Prison Cuddalore, to enable him to attend the marriage of his elder brother, Murugavel, scheduled to be held on 20.02.2026.
