The writ miscellaneous petition has been filed to condone the delay of 120 days in filing the restoration petition in W.P.No.17242 of 2019.

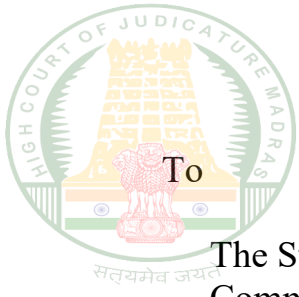
2. Heard the learned counsel for the petitioner and perused the materials available on record.
