PRAYER: Writ Petition has been filed under Article 226 of the Constitution of India praying to issue a writ of mandamus directing the second respondent to issue Site Visit Certificate to the petitioner to enable the petitioner to participate in tender viz, IFB No.07/F.CWSS to Sunnambukkadu/DO/ETKC/Erode /2025-26 dated 06.02.2026 in respect of two work viz., 1. Replacement of PVC Pipes with 160 mm HDPE PN 6 pipe from Headworks to Uppardam (Pumping Main-I) in CWSS to Sunnambukkadu and 38 other Habitations in Dharapuram and Kundadam Union in Tiruppur District for the year 2025-26 (Reach-I) and 2.
