2. In this regard the proceedings of the Director of Sugar and Cane Commissioner dated 29.06.2024 would show that the additional portion of sugarcane fields allotted in favour of the appellants were re-allocated after revival of the original Company viz., Ambika Sugars Ltd., In view of these changes, further adjudication in respect of grounds raised in the present intra-Court appeal is unnecessary.

3. The learned counsel for the appellant in W.A.No.539 of 2023 would submit that the appellant will pay the costs within a period of four (4) weeks from the date of receipt of a copy of this order.

4. In view of the above factum, the present Writ Appeals stand **closed**. No costs. Consequently, the connected miscellaneous petitions are also closed.
