For the foregoing reasons, this writ petition is disposed of by directing the third respondent to pass final orders, on merits and in accordance with law on the petitioner's representation dated 13.10.2025 seeking for permission to construct a graveyard for the petitioner's daughter in law's burial place at the address, morefully disclosed in the affidavit filed in support of this writ petition and after giving due consideration to the supporting documents filed by the petitioner, within a period of 12 weeks from the date of receipt of a copy of this order.
